

Lupercalia 2012 Waiver

This document has SIGNIFICANT legal implications, please read carefully!

1. I am freely and voluntarily choosing to attend and participate in this event and to view and/or participate in activities that I know are adult oriented and sexually explicit and that may involve acts of domination, submission, bondage, discipline, sadism and masochism, and other explicit and extreme sexual fetishes and activities, including, but not limited to, spanking, paddling, flogging, whipping, waxing, piercing, fire play, knife or needle play, bondage and suspension, and which may involve the presence of blood or other fluids. I understand that these activities involve certain risks, including, but not limited to, the possible negligent or reckless conduct of other participants.
2. I am familiar with and understand the subject matter and nature of the practices of bondage and discipline, sadomasochism, power exchange between willing and consenting adults, homosexuality, bisexuality, heterosexuality, fetishism, and other related sexual and/or dominance and submission activities. I further state and agree that I find none of these subjects or activities to be offensive or objectionable to me in any manner whatsoever.
3. I agree that I am attending a private event, not open to the public. As an attendee of Lupercalia 2012, I willingly and with full consent and knowledge waive and relinquish any claim, legal or otherwise, that I might make as to the offensive nature of anything I might see or experience while I attend Lupercalia 2012. Should I at any time attempt to make such a claim, I understand and agree that I would do so as a means of entrapping and/or soliciting the arrest of the other attendees of Lupercalia 2012.
4. I understand and agree that Lupercalia 2012 is a private event and that the privacy of all other attendees of Lupercalia 2012 is of paramount importance to such attendees. For that reason, I represent and agree that I am not attending Lupercalia 2012 as a news/media/broadcast reporter in any capacity or as an investigator for any news/media/broadcast outlet in any capacity. If I should divulge to any news/media/broadcast organization anything I see, hear, or photograph while attending this event, I acknowledge and agree that it would be impractical and extremely difficult to estimate the damages that Lupercalia Inc. might incur for such disclosure. Therefore, I agree that a reasonable estimate of the total detriment that Lupercalia Inc. would suffer in the event of such disclosure is and shall be, as the sole and exclusive remedy and not as a penalty, One Million Dollars (\$1,000,000) ("Liquidated Damages Amount"). I recognize and agree that the news/media/broadcast outlet and I shall each be held separately liable to Lupercalia Inc. for such Liquidated Damages Amount.
5. **I will respect the right to privacy of all Lupercalia participants.**
This includes not divulging legal names, unless previously sanctioned by the individual, and not divulging details of play party scenes.
6. I agree not to bring to or consume any alcoholic beverage or illegal or illicit substance of any sort at any meeting, seminar, or other type of gathering of any sort sponsored by Lupercalia 2012, except that I may consume alcoholic beverages purchased at Lupercalia 2012 from the venue bar manned by the venue staff.
7. I agree that I will never solicit for, negotiate, or consent to any form of payment for sex during any meeting, seminar, or other gathering sponsored by Lupercalia 2012. I am aware that such conduct is illegal pursuant to local, provincial and national laws.
8. I am at least eighteen years of age. I agree to produce a valid driver's license or other valid I.D. in order to obtain entry into Lupercalia 2012, in order to prove my age and identity.
9. The name presented is my true and legal name and is not an alias.
10. All attendees of Lupercalia 2012 and Libertina Ball will be required to present a wristband (*placed on their arm when they register*) for admittance to any meeting, seminar, or other gathering sponsored by Lupercalia 2012. *There will be NO exceptions to this rule. So please keep your wristband on all weekend.*
11. I assume the risk of injury incident to my attendance and participation at meetings, seminars, and other events sponsored by Lupercalia 2012. As consideration for being permitted to enter the event, and to view and participate in these activities, and to use the facilities and equipment being provided, I agree that neither I nor anyone through me or on my behalf will make any claim against or sue Lupercalia Inc. or anyone affiliated with it, including, but not limited to, its officers, directors, organizing committee, shareholders, agents, employees, volunteers, promoters, sponsors and contractors, and including, but not limited to, the owners, lessors or suppliers of the premises, and the owners, lessors or suppliers of any equipment used in connection with the event, for any injury or damage suffered by me at any time during my presence at the event or as a result of my participation in any activities at the event, and I hereby release, waive and forever discharge them, their heirs, administrators, executors and assigns, from any and all claims, demands, actions or rights of action, of whatever kind or nature, either in law or in equity, arising from, or by reason of, my attendance at, or participation in, the event or activities. I agree to hold harmless. Lupercalia Inc, it's officers, directors, organizing committee, volunteers, and attendees, as well as their successors, and assigns from any claim of liability that could be made by me that may arise out of my attendance and participation at meetings, seminars, and any other events sponsored by Lupercalia 2012.
12. I acknowledge that attending the workshops of Lupercalia 2012 does not make me an expert in the subject matter. If I decide to act upon or imitate in any way what I see and hear in the workshops, I do so at my own risk and will not hold Lupercalia Inc., its representative, volunteers or workshop leaders liable.
13. I agree to not use any cell phone, camera, cell phone camera, cell phone capable of recording voices or recording any sort of images, or video recording device into any event sponsored by Lupercalia 2012, including the vendor areas, seminars, demos and the dungeon. I further agree that should any camera, video recording device, or audio recording device be used at a Lupercalia 2012 event by me or by someone acting on my behalf, such equipment will be subject to immediate confiscation and destruction. Cell phones may be used from time to time by committee members for the express purpose of emergency communications with each other. Cell phones may also be used by vendors when required to process business transactions. A Cell Phone waiver must be signed by Committee Members and Vendors.
14. I agree to abide by the Hotel Rules posted on the Lupercalia website and provided to me in the Runbook.

15. I understand and agree to comply with the specific Play Party Rules which apply to the playspace/dungeon which may be posted in the playspace or be provided to attendees at the time of registration, which **may** include the following:

- No alcohol or any illegal drugs or illegal substances of any kind may be brought into the playspace.
Anyone who is noticeably affected by either alcohol or drugs will be denied admittance or asked to leave by the Dungeon Monitor.
- All attendees of Lupercalia 2012 will be required to present a wristband (*placed on their arm when they register*) for admittance to the playspace and other events. There will be NO exceptions to this rule.
So please keep your wristband on all weekend.
- **No sex.** This means no insertion of any body parts into any orifices of the body.
If you feel your play might be in violation of this then ask a Dungeon Monitor.
- Prostitution, solicitation and negotiation of compensation for sexual services are illegal and will not be tolerated.
Any violator will be immediately ejected from the premises and their admittance to the remainder of the events of Lupercalia 2012 forfeited.
- Food and drink (with the *exception of water in non-breakable, clear containers*) may not be brought into the playspace.
Snacks and drinks for emergency purposes will be available inside the dungeon.
- No cameras, cell phones of any kind, and video or audio recording devices of any kind will be allowed in the playspace.

Even if the cell phone is not capable of taking pictures, all cell phones are banned from the playspace. You may have your cell phone with you in a social area adjacent to the playspace but you may not use the phone in the social area. Please place or receive any calls in the hallway or outside of the conference area. Any person seen with any such devices shall be immediately ejected from the premises and their admittance to the remainder of the events of Lupercalia 2012 forfeited.

**** NO CELL PHONES OF ANY KIND IN THE PLAYSACE DURING THE FRIDAY, SATURDAY AND SUNDAY PLAY PARTIES. THEY WILL BE CONFISCATED AND MAY BE DESTROYED!**

- For everyone's protection, we ask that you use the cleaning supplies located in the playspace.
If you are not familiar with the cleaning supplies, please ask a Dungeon Monitor for more information on their safe use.
- All players will be required to clean up their play area after their scene has ended. Please leave all equipment free from all body fluids including sweat, and remove all toys. If you do a scene involving blood, gloves must be worn and the floor must be covered with the provided drop cloths. **Bring any bodily fluid contamination to the notice of the Dungeon**

Monitors.

- No Wax or Fire of any kind is permitted.
- Normal playspace etiquette is required. **Do not intrude into or interrupt any scene unless specifically invited by a participant.**
- Do not touch anyone or anyone's gear without permission.
- There will be time limits on use of equipment in the playspace .
- Playspace is for participants only. Watching from a respectful distance is permitted (*space allowing*), *but* please keep all conversation, laughter, and comments to a minimum in the playspace. DO NOT talk to the players while the scene is progressing.
- Persons must be fully dressed or appropriately covered when leaving the playspace area.
- **Dungeon Monitors must be obeyed at all times.** If someone is breaching playspace etiquette and your scene is being disturbed or you are being bothered unduly, please notify a Dungeon Monitor.

Anyone who appears to be acting in a way that the Lupercalia Inc.'s Directors deem inappropriate or in any way detrimental to Lupercalia 2012, may be removed from the event and their admittance to the remainder of Lupercalia 2012 forfeited. If you believe someone is breaching these rules or acting in a way which might place Lupercalia or its participants at risk, it is your responsibility to bring that to the immediate attention of a member of the Lupercalia organizing committee.

**I HAVE CAREFULLY READ THIS DOCUMENT AND I FULLY UNDERSTAND ITS CONTENTS.
I AM AWARE THAT IT INCLUDES A RELEASE OF LIABILITY AND A CONTRACT BETWEEN ME AND LUPERCALIA INC. AND THAT I AM GIVING UP MANY LEGAL RIGHTS AND REMEDIES BY SIGNING IT.**
